

SPEAKER INFORMATION

Norman L. Donati, MD

With his many years of experience, he treats a broad range of orthopaedic problems and has extensive experience performing joint replacement procedures of the shoulder, hip and knee (partial or full), and foot.

Garland K. Gudger, Jr., MD

Dr. Gudger, earned his medical degree from Mercer University School of Medicine in Savannah, GA. Dr. Gudger completed his residency in orthopaedic surgery at the Greenville Hospital System in Greenville, SC where he served as Chief Orthopaedic Resident, was an AOA Resident Leadership Forum Recipient, and was awarded the Lilly M & GD Jackson Award for outstanding first year resident. Before joining the Hughston Clinic, Dr. Gudger completed a fellowship as the 2016-2017 Hughston ACE Fellow at the Hughston Foundation where he received specialty training in arthroscopic surgery and sports medicine as well as hip and knee replacement.

Honorable Tasca Hagler

Judge Hagler has been an administrative law judge with the State Board of Workers' Compensation for the past 30 years and currently hears cases for a 22-county area surrounding Columbus, GA.
